Notice is hereby given in terms of Section 49(1) (a)(i)(ii) read together with Section 78(2) of the Local Government Municipal Property Rates Act 2004 (Act No.6 of 2004), herein after referred to as the “Act”, that the General Valuation Roll for the Financial years 2019 - 2023 is open for public inspection at the Municipal Offices as listed below from 10th March 2019 to 30th April 2019 during office hours. In addition the third General Valuation Roll will be available on the Municipal website at www.umhlalbuyalingana.gov.za.

An invitation is hereby made in terms of Section 49 (1) (a) (ii), read with 78 (2) of the Act, that any owner of the property or other person who so desires should lodge an objection with the Municipal Manager in respect of any matter, including the category, reflected in or omitted from the valuation roll within the above mentioned period. Attention is specifically drawn to the fact that in terms of Section 50(2) of the Act an objection must be in relation to a specific individual property and not against the valuation roll as such. The forms for the lodging of objection are obtainable from Finance Department – Revenue offices of the Municipality in Manguzi and Traffic Department - Mbazwana or Municipal website www.umhlalbuyalingana.gov.za.
