HAVAL announces badge change to SUVs

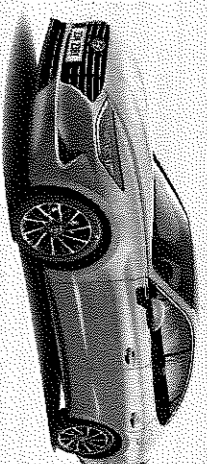

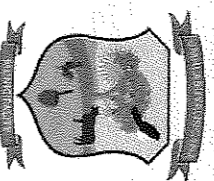
The unsightly red badge must have been pointed out by other motoring publications as well in the past, because Haval has announced it will change to a more subtle and stylish

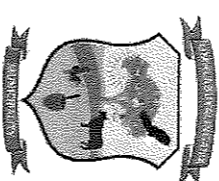

Next Hyundai Sonata revealed

Hyundai has shown the world what the next Sonata will look like when it is launched next year.

The Sonata, unfortunately, is not among the brand's offerings in SA as it, and other luxury sedans such as the Ford Fusion, Kia Optima and Honda Accord, have all been dropped owing to their failure to lure brand-conscious buyers away from the three big German brands - Audi, BMW and Merc.

Hyundai says the eighth generation Sonata embodies Hyundai's Sensuous Sportiness design concept with an innovative coupé-like silhouette.

Sang Ywp Lee, Senior Vice President and head of the Hyundai Design Centre, explained the big sedan's 'short overhang, sloping roofline and low deck lid create a balanced feel, and Hyundai's signature chrome accent goes all the way into the hood, making it look even longer'.

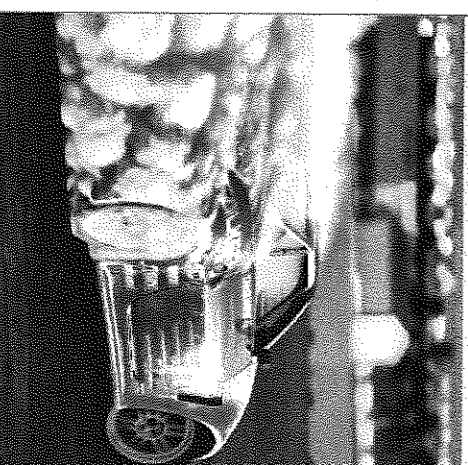
Detailing the exterior only, for now, Hyundai said the daytime running lights, embedded with 'hidden lighting lamps' are a first for a Hyundai vehicle and a chief design innovation that 'incorporates state-of-the-art lighting technology'.

The brand has still to reveal engine and transmission options, as well as luxury features inside the cabin, but be sure the latter will be quite extensive as Hyundai tries to impress buyers of premium sedans in the markets where the Sonata is available.
