CALLING FOR INSPECTION OF THIRD SUPPLIMENTARY VALUATION ROLL AND LODGING OF OBJECTIONS

Notice is hereby given in terms of Section 49(1) (a) (i) read together with Section 78(2) of the Local Government Municipal Property Rates Act 2004 (Act No.6 of 2004), herein after referred to as the “Act”, that the supplementary valuation roll for the financial year 2021-2022 is open for public inspection at Umhlalabyalingana municipal offices from 19 April 2022 to 02 June 2022 during office hours. In addition the supplementary valuation roll will be available on the Municipal website at www.umhlalabyalingana.gov.za.

An invitation is hereby made in terms of Section 49 (1) (a) (ii), read with 78 (2) of the Act, that any owner of the property or other person who so desires should lodge an objection with the Municipal Manager in respect of any matter reflected in or omitted from the supplementary valuation roll within the above-mentioned period.

Attention is specifically drawn to the fact that in terms of Section 50(2) of the Act an objection must be in relation to a specific individual property and not against the supplementary valuation roll as such.
